PBCDF is currently in a scheduled outage for changeover activities to prepare for mustard ton container disposal operations. The site continued processing Simulated Equipment Test Hardware (SETH) or "mock" ton containers through the Metal Parts Furnace to test the furnace's readiness for disposal operations. Preparation and training exercises for the Integrated Operations Demonstrations (IOD) and Operational Readiness Review (ORR) also continued. Actual IOD evolutions started in the Upper Unpack Area on Monday, November 17.
